Assignments are outlined in detail by the supervisor. Standard procedures should be followed, and work is inspected periodically for safety and efficiency in operation. This position differs from general laborer, because of the skill required and the possibilities of time spent in operating the equipment.

Job Description: Performs routine work of an unskilled, semi-skilled, or skilled nature, requiring the ability to do heavy physical labor efficiently, and involving the operation of motor vehicles and heavy to light equipment used in a range of public works activities in a variety of weather conditions.

Duties & Responsibilities

- Works as a heavy laborer
- Operates automotive/heavy equipment such as mowers, front end loaders, bulldozers, graders, dump trucks, backhoes, street sweepers, bucket trucks, and excavators (as applicable).
- Hauls equipment on trailers.
- Services and operates light to heavy equipment, drives Town owned vehicles.
- Use tape measurer, calipers, micrometers, and other devices to determine measurements of objects as needed.

• Other duties as assigned.
