TOWN OF RAGLAND COUNTY OF ST. CLAIR STATE OF ALABAMA

AN ORDINANCE AMENDING THE SAFE STREET ORDINANCE

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF RAGLAND, ALABAMA AS FOLLOWS:

SECTION 1. That Section 3 of Ordinance No. 2003-002 "AN ORDINANCE OF THE TOWN OF RAGLAND TO ESTABLISH SAFE STREETS" is hereby amended to state as follows:

SECTION 3. Notwithstanding any provision of law, and except as otherwise provided in this section, a motor vehicle is subject to impoundment as a nuisance if it is driven on a highway or other public roadway in the Town of Ragland, Alabama or its police jurisdiction, and any of the following is also true.

The operator of the motor vehicle has not first obtained a valid driver's or chauffeur's license in this or another state, or his/her driver's license or privilege has expired and said license has been expired over ninety (90) days, or his/her driver's license or driving privilege is revoked or suspended for any reason under the law of this State or similar laws of any other state or territory, or his/her driver's license or driving privilege is suspended or revoked as a consequence of a DUI related offense including, but not limited to, being adjudicated delinquent or a youthful offender based on DUI related offense, or his/her driver's license or driving privilege is suspended or revoked as a result of his/her failure to comply with the implied consent law of this state or laws of another state, or he/she has been adjudicated a delinquent child or a youthful offender based on an offense that if the person had been an adult would have been a conviction of driving under the influence of a controlled substance or alcohol or failure to comply with the implied consent law.

SECTION 2. <u>REPEALED</u>. All ordinances of the Town of Ragland which are inconsistent with the above are hereby repealed to the extent, and only to the extent, of said inconsistency and all parts not inconsistent are unaffected by this Amendment but remain in full force and effect as if fully and completely set forth herein.

SECTION 3. <u>EFFECTIVE DATE</u>. This Ordinance shall become effective upon its passage and publication as required by law.
